| 28 | Sec. 2. Establishment and Implementation |
| 29 | (a) The Mayor shall establish the Commission on Poverty in the District of Columbia |
| 30 | that is directed toward meeting the needs and interests of persons in poverty, with the specific |
| 31 | goal of reducing poverty. This Commission shall evaluate existing and subsequent anti-poverty |
| 32 | initiatives in the District and throughout the country to determine their effectiveness and make |
| 33 | comprehensive and continuing recommendations to strengthen and enhance the educational, |
| 34 | economic, health, and housing status of persons in poverty. |

(b) The Commission shall be composed of 13 members who ae appointed by the Mayor with the advice and consent of the Council; all members shall be residents of the District of Columbia. Five of the ward members shall be either in poverty, as defined by current federal guidelines, or have been in poverty within the last 3 years. One person shall come from each of the 8 Wards. To qualify for membership on the Commission from one of the 8 Wards, the members shall have been a resident of the Ward he or she is representing on the Commission for a minimum of one year, and must remain in the Ward he or she is representing for the duration of his or her term. The 5 remaining members shall have been residents of the District for at least 3 years prior to appointment, and shall have experience in the area of public policy or programs related to the particular interests, needs, and concerns of persons in poverty.

- (c) Members of the Commission shall serves terms of 3 years, however, the initial appointments shall be as follows: 4 members shall be appointed for 3 years; 4 shall be appointed for a term of 2 years; and 3 for a one year term; any subsequent re-appoint of a member shall be for a term of 3 years.
- (d) Whenever a vacancy occurs on the Commission, the Mayor, with the advice and consent of the Council, shall, within 90 calendar days of such vacancy, appoint a successor to fill the unexpired portion of the term. If within 60 calendar days of submission (excluding Council recess) of a nomination for the Commission, the Council fails to act, the nomination shall be deemed approved.
- (e) The Commission shall meet at least 9 times annually, and shall develop its own operating rules, not less than 4 of the Commission's meetings shall be held in areas of the District with high concentrations of poverty; a quorum shall consist of a majority of the voting members.

| 22 | This act shall take effect following approval by the Mayor (or in the event of veto by the |
| 23 | Mayor, action by the Council to override the veto), a 30-day period of congressional review as |
